
TEACHER'S FEEDBACK ANALYSIS (2020-2021)

Directorate of Internal Quality Assurance (DIQA) of University of Kashmir has the mandate to design and collect feedback from its stakeholders to monitor and evaluate quality of curriculum and curriculum-related issues. The feedback forms were collected from teachers on several aspects of the curriculum and its learning-related issues in terms of quality, competence, skills and professionalism. The sample selected respondents submitted their responses through online data collection platform via Google form.

The sample Size of teacher's feedback was 73 across different departments collected with the help of Google form. The responses are scored over a five point scale (Strongly agree, Agree, Neutral, Disagree, Strongly disagree) which reflected the viewpoints of faculty members from the different departments. The DIQA considered the suggestions and discussed them with the authorities. Subsequently, the authorities took the necessary steps to enhance the quality of curriculum design and the teaching-learning process.

FEEDBACK ANALYSIS AND INTERPRETATION

1. The Curriculum and Syllabus offered are updated and need based. 73 responses




2. The Learning objectives and course outcomes are well defined and clear. 73 responses



4. The course/ curriculum has a balance between theory and application. 73 responses





5. The course/ curriculum enriched my knowledge and perspective in the subject area. 73 responses





7. I have the freedom to adopt new ways, techniques and tools in the teaching. 73 responses




8. I am able to achieve course outcomes at the completion of each course assigned to me. 73 responses

9. I take care of slow learners and if needed remedial classes are arranged for them. 73 responses





Key Findings of the study.

- 1. The majority of respondents (88%) agree or strongly agree that the curriculum and syllabus are need-based.
- 2. A significant majority (91%) agree or strongly agree that the learning objectives and course outcomes are well-defined and clear
- 3. The majority (88%) agree or strongly agree that sufficient reading materials and digital resources are readily available in the library
- 4. A significant majority (93%) agree or strongly agree that the curriculum is always designed and developed as per the statutes of the university and regulatory bodies

- 5 Most respondents (95%) agree or strongly agree that they take care of slow learners and arrange remedial classes if needed
- 6 The majority (94%) agree or strongly agree that they are able to achieve course outcomes at the completion of each course assigned to them
- 7. The vast majority (89%) agree or strongly agree that they have the freedom to adopt new ways, techniques, and tools in teaching.

Suggestions:

1. Enhanced Support for Neutral and Disagreeing Respondents:

Although the majority are satisfied with various aspects, a small percentage of respondents expressed neutrality or disagreement. It's important to investigate the specific concerns of these respondents to address any underlying issues and improve overall satisfaction.

2. Increase Engagement with Curriculum Design:

While 81% feel they have the freedom to influence the syllabus, efforts should be made to increase this percentage. More opportunities and platforms for faculty to contribute to curriculum design could be beneficial.

3. Regular Review of Curriculum Compliance:

Regularly review the curriculum to ensure ongoing compliance with university statutes and regulatory bodies, while also seeking ways to innovate and improve educational standards.

4. Resource Availability in Libraries:

Continue to expand and update the reading materials and digital resources in libraries to keep up with the evolving educational landscape and ensure all necessary resources are available.

Actions taken:

- 1. The university implemented regular surveys and focus groups specifically targeting the concerns of neutral or disagreeing respondents to gain deeper insights and address their issues effectively.
- 2. The university offered regular training sessions, workshops, and seminars focused on innovative teaching methods and the integration of new technologies. Faculty was encouraged to share successful strategies and experiences.
- 3. Authorities instructed the central library as well as to departmental library to update the requirements of departments so that sufficient reading material can be available in digital form.
