
#### **TEACHER'S FEEDBACK ANALYSIS (2022-2023)**

Directorate of Internal Quality Assurance (DIQA) of University of kashmir has the mandate to design and collect feedback from its stakeholders to monitor and evaluate the quality of curriculum and curriculum-related issues. The feedback forms were collected from teachers on several aspects of the curriculum and its learning-related issues in terms of quality, competence, skills and professionalism. The sample selected respondents submitted their responses through online data collection platform via Google form.

The sample Size of teacher's feedback was 108 across different departments collected with the help of Google form. The responses are scored over a five point scale (Strongly agree, Agree, Neutral, Disagree, Strongly disagree), which reflected the viewpoints of faculty members from the different departments. The DIQA considered the suggestions and discussed them with the authorities. Subsequently, the authorities took the necessary steps to enhance the quality of curriculum design and the teaching-learning process.

#### FEEDBACK ANALYSIS AND INTERPRETATION

1. The Curriculum and Syllabus offered are updated and need based. 108 responses



2. The Learning objectives and course outcomes are well defined and clear. 108 responses





4. The course/ curriculum has a balance between theory and application.











9. I take care of slow learners and if needed remedial classes are arranged for them. 108 responses



The data shows that a vast majority of respondents (90%) agree or strongly agree that the curriculum is always designed and developed as per the statutes of the university and regulatory bodies, with 37% agreeing and 53% strongly agreeing.

### Key Findings of the study.

- 1. A strong consensus exists among respondents that the curriculum and syllabus are aligned with their needs, with 86% either agreeing or strongly agreeing.
- 2. A significant majority (88%) believe that the learning objectives and course outcomes are well defined and clear.
- 3. The majority of respondents (86%) feel that there are sufficient reading materials and digital resources readily available in the library.
- 4. Most respondents (82%) agree that the course provides a good balance between theory and application.
- 5. An overwhelming majority (91%) feel they have the freedom to adopt new ways, techniques, and tools in teaching.
- 6. Vast majority (90%) agree that the curriculum is designed and developed as per the statutes of the university and regulatory bodies

#### **Suggestions:**

- 1. Enhance Curriculum Flexibility: Continue to encourage and support faculty in proposing, modifying, and incorporating changes in the syllabus through proper forums to maintain alignment with evolving educational needs and standards.
- 2. Expand Resource Availability: Although most respondents are satisfied with the availability of reading materials and digital resources, further investment in expanding and updating these resources can ensure they remain comprehensive and current.
- 3. Promote Innovative Teaching Methods: Provide ongoing professional development opportunities for faculty to explore and implement new teaching techniques and tools, enhancing the learning experience and keeping pace with educational advancements.
- 4. Support for Slow Learners: Strengthen and formalize support systems for slow learners, including structured remedial classes and personalized learning plans, to ensure all students can achieve course outcomes effectively.

#### **Actions Taken:**

- The authorities implemented a structured feedback mechanism where faculty and students suggested changes to the syllabus, ensuring it remains relevant and effective.
- 2. The authorities allocated additional funds to the library for acquiring the latest books, journals, and digital resources to keep the collection up-to-date and comprehensive.
- 3. The authorities organized regular workshops and training sessions for faculty on innovative teaching techniques, digital tools, and pedagogical strategies.
- 4. A structured remedial program that included personalized learning plans, additional tutoring sessions, and monitoring of student progress was conducted to help slow learners achieve academic success.
