Sub: Information regarding timely redressal of student grievances including sexual harassment and ragging cases

Sir,

This is in response to your office letter No: F (NAAC-DIQA/KU/18 Dated: 16-03-2018 seeking the information pertaining to the subject as cited above. The relevant information is provided herein under:

- The University of Kashmir has a tight anti-ragging system in place which is in tune with the UGC Regulations on curbing the Menace of Ragging in Higher Educational Institutions, 2009. There is an anti-ragging mechanism comprising of anti-ragging committee and ant-ragging squad.
- The University has approved the proposal of the Chief Proctor to install CCTVs on the campus. The process has been started in which sensitive areas on the campus will be put under the CCTV surveillance.
- Patrolling of the Watch & Ward and KUG Coy has been enforced to ensure the monitoring and speedy action in case of any untoward incident.
- 4. The mobile numbers of all the officers including the Chief Proctor, Dy. Chief Proctor, Proctors and Chief Security Officer have been made available on the University website so that the students know whom to call in case of any emergency.
- Any student desirous of availing hostel facility has to furnish a duly sworn in affidavit to the effect that he/she will not indulge in or abet any behavior or act amounting to ragging.



6. The University adopts protective and preventive measures against harassment in any form involving students, faculty and staff members in order to uphold their individual right to pursue their academics, research and administrative goals. Over the past few years, the office of the Chief Proctor has received a number of complaints from students/employees facing harassment in one way or the other in response to which the office has taken prompt and appropriate action as warranted under rules. It is worth to submit that there is one lady Proctor who looks into the issues related to female students and employees.

The complainant accessed the Anti-Ragging Helpline for registering his complaint. The complainant alleges that he was ragged by some of the senior students of his college which is affiliated to University of Kashmir, Srinagar. Accordingly, the Registrar, University of Kashmir was asked to look into the matter who forwarded the case to the Chief Proctor, University of Kashmir for the necessary action. The Chief Proctor deployed the undersigned to the Government Medical College, Srinagar where the incident was reported to have occurred. A meeting was convened in the office chamber of Prof. (Dr.) Rukhsana Najeeb, I/C Anti-Ragging Committee GMC on May 17, 2017 at 2:30 PM in which the undersigned was apprised of the whole case history. After a threadbare discussion, it came to fore that the complainant is a student of M.B.B.S. 2nd Semester and has already been identified by the concerned Anti-Ragging Committee. The Principal, GMC Srinagar had received a complaint dated 12/05/2017 (Copy enclosed herewith) from the complainant of the alleged ragging by senior students in the hostel. The Registrar (Acad.) GMC through Letter No. Acad/910-11 dated 16.05.2017 (copy enclose herewith) directed the Anti-Ragging Committee. GMC to make an investigation into the matter and submit a detailed report in this regard. The Anti-Ragging Committee made a thorough probe into the incident and concluded:

- that the students of M.B.B.S 2nd year were playing a friendly cricket match and the students of M.B.B.S 3rd year requested them to allow them to be the part of the game which the former declined;
- that there was verbal argument an exchange of words between the two sides which led to minor scuffle between them;
- that after the intervention of the authorities, both the sides tendered an apology to
- that the said act of the students neither amounts to ragging nor any case under the penal laws can be made out against any of them; and
- that the complainant has been properly counselled by the concerned authorities

An incident occured at the Engineering College Zakura Campus on May 2nd 2017 wherein a girl student namely Ms. Tanzeela Mir was alleged to have been harassed by one Mr. Salig, Faroog. pursuant to the incident, an enquiry committee was constituted by the Chief proctor, University of Kashmir. After a thorough investigation, the Committee found Mr. Salig, faroog guilty and recommended his suspension for one year. The recommendation was endorsed by the Dean Acade. onic Affairs, University of Kashnir. Accord. ingly Mr. Salig, paroog was put under Suspension with an immediate effect with order No. F (Discriping) DART KU 117, 29 . 119 7/10/9 Later on Mr. Salig Faroog approached the Office of the Chief Proctor alongwith his parents and tendered an apology in writing (Copy attached herewith). His parents also submitted an affidavit to the effect that he will not repeat such type of acts in Juture. The apology was accepted by Ms. Tanzeela. On repeated purmation of the parents of both the

The complainant accessed the Anti-Ragging Helpline for registering her complaint. In her complaint, the complainant alleged that she was ragged by the accused. Presently the complainant and the accused are on rolls in the Institute of Asian Medical Sciences, Zakura, Srinagar which is affiliated to the University of Kashmir, Srinagar. The Chief Proctor, University of Kashmir deployed the undersigned to the Institute of Asian Medical Sciences, Zakura where the incident was reported to have occurred. Thereafter, a meeting was held with the Principal of the Institute in the Office Chamber of the undersigned on August 28, 2017 at 1:00 PM in which the undersigned was apprised of the whole case history. After a threadbare discussion, it came to fore that the complainant is a Ist Prof. BUMS student who has already been identified by the concerned Anti-Ragging Committee. The Chairman, Institute of Asian Medical Sciences Zakura had received a complaint from the complainant of the alleged ragging by the accused. The Chairman through Letter dated 28.08.2017 (copy enclose herewith) directed the Principal to make an investigation into the matter and submit a detailed report in this regard. The Anti-Ragging Committee made a thorough probe into the incident and recommended the suspension of accused pending the completion of investigation. After the investigation (Copy of the report is annexed herewith), the Committee found that the act of the accused neither amounts to ragging nor any case under the penal laws can be made out against him. It was simply a case of misunderstanding between the two.

The accused also tendered an apology to the complainant and thereafter, the accused was allowed to resume his class work.

The Anti-Ragging Committee has been directed to seek an explanation from the complainant as to why she has unnecessarily bothered the authorities on the issue which could have been resolved by the college authorities.





Sir, With due regards and veneration, we the B.Ed (Backlog) candidates would like to invite your kind attention towards the subject cited above that recently the University has notified the date sheet for B.Ed Examinations. Since there is extrem cold in Valley and we being the backlog candidates do not have any hostel accommodation in our respective colleges as such we are not in a position to appear in the ensuing B.Ed Examination in the Valley of Kashmir. Keeping in view the above mentioned facts, it is humbly and deeply requested to your esteemed self to kindly keep our centre of Examination at any centre in Jammu Province. Sir, we all belong to different warm zone states of India like Odhisa, West Bengal, Bihar, Andhra Pradesh etc and do not have any adaptation to live in these chilly circumstances. Residing in the valley in these chilly days will be at the cost of our examination as well as at the cost of our health.
