







- I. The nomenclature of the Courses/Papers/Subjects offered shall be based on pattern provided under BCI Rules of Education, 2008.
- II. The BA.LLB (Hons) Degree shall have atleast 58 Courses/ Papers/Subjects including 20 Non-Law Courses/ Papers/Subjects, 20 Compulsory Law Courses/Papers/Subjects, 4 Clinical Courses/Papers/Subjects, 8 Honours/Specialised Courses/Papers/Subjects and 06 Optional Courses/ Papers/Subjects.
- III. The Object Clause should be introduced in each and every Courses/ Papers/Subjects.
- IV. The Reference/Recommended Readings style shall be uniform in each and every Course/ Paper/Subject.
- V. The Leading and Latest Case Law shall be provided/taught in each and every Law Course/ Paper/Subject.

Item No.4: That all the proposed changes/revision and update of BA.LLB (Hons) Programme Statutes in accordance with Proposed Syllabus are considered and found in tandem with the proposed syllabus of BA.LLB (Hons) & hence resolved to put the same before the competent authority for approval.


